

Effective Engagement with Māori

OVERVIEW

The way government engages with Māori is changing. Future engagement is going to be different from what we have traditionally seen/experienced. The establishment of Te Arawhiti – The Office for Māori Crown Relations, demonstrates the governments' commitment to build strong, ongoing and effective relationships with Māori across all of government. Engagement will go beyond consultation to true partnership.

This two-day workshop is designed to help public servants gain a greater understanding of Te Ao Māori (Māori world view), Te Tiriti o Waitangi, and provides practical tools and techniques for effectively engaging with Māori.

Day one of the workshop has participants building a foundation of historical and cultural knowledge. Day two, has participants using this knowledge to inform their planning for engagement with Māori.

Te Reo (Māori language) and Tikanga (Māori protocols) will be weaved through the workshop across the two days.

WHO SHOULD ATTEND?

This introductory workshop is designed for public servants who want to build their knowledge and confidence for working in partnership with Māori. Including;

- Improving their understanding of the Te Ao Māori and Te Tiriti o Waitangi.
- Building their knowledge and skills for consulting and engaging with Māori.
- Creating a kete (basket) of useful tools and resources to support their engagement with Māori.

WORKSHOP PRESENTER



Katy Te Amo - Tainui, Ngāti Wairere

Katy began her career in teaching and spent a short time in South Korea as an English Teacher. Upon her return to Aotearoa, Katy pursued post-graduate study before moving into a number of different roles at Te Papa Tongarewa that utilised her education training. Katy spent six years at Te Papa and her most memorable role was an educator on the travelling exhibition Treaty 2U, when it toured Auckland secondary schools for 12 months.

Since finishing at Te Papa, Katy has spent the last 10 years in a range of roles across central government. This has included policy roles at Te Puni Kokiri and three years as Private Secretary to the former Minister of Māori Affairs, Hon Pita Sharples. In 2014, Katy moved into the Treaty Settlement sector with her most recent role being a Negotiation and Settlement Manager at the Office for Māori Crown Relations – Te Arawhiti.

Katy is now contracting, predominately in roles that draw on her experience in policy and stakeholder engagement.
